Debbie Ulmer gave a nice tribute to Mary and her work in the community, as well as SBW. The arrangement was then taken to Mary's funeral service the following day.


Leadership Conference August 7, 2021

Pettis County Children's Fund - The Pettis County Children's Fund is utilized to help foster children from Pettis and Cooper Counties participate in extra-curricular activities. This fund helps to provide equipment, instruments, prom and graduation costs, camp fees, etc so foster children can enjoy the same activities as other children their age.

Community Cafe - The Community Café strives to improve the food security of the Sedalia and Pettis County communities by providing nutritious meals to combat hunger and malnutrition through community partnerships.

Sedalia Senior Center - Now located in the new Heckert Community Center, the Sedalia Senior Center is under the umbrella of Care Connection for Aging Services. The meals program at the Sedalia Senior Center cooks and serves nutritious, delicious meals for people 60 and older. Contributions are encouraged; however, people 60 and older may enjoy lunch regardless of their ability to contribute. Meals are available on site and home-delivered to older adults. Open Door's "Go with the Flow"

Mission - This new program helps keep women and teens in Pettis County women and teens supplied with free menstrual products so they can attend school or college without missing class due to the inability to afford necessary feminine products.

Community Santa - Community Santa is a charitable organization whose prime focus is making Christmas wishes come true. The process starts with families filling out applications and ensuring that those who truly need help are in fact the ones who get it, as well as communicating with other local charities to ensure there is no overlapping. Volunteer workers will acquire children's wish lists for Christmas. Each child will receive two toys off their list as well as a new book, a family game and a 'lovey' (stuffed animal). Items are black bagged and given to parents who are then able to wrap the gifts.
